Private Parking Lots

A concern was shared prior to the Annual General Meeting regarding the use of private parking lots by those that are not permitted to park there. The BIA continues to remind businesses about the Cooper Lot being available and free. The Shoppers Drug Mart parking lot was the concern that was brought forward. Tobin Schlegal, Centre Mall, echoed these concerns, especially as the downtown gets busier again and with the boardwalks being reinstalled. Increased signage directing to the proper lots to park in (signage directing from the lots being misused to the proper lot – this could also be information that is found on the map. City Council is going to conduct another parking review after the new Council is in place. It was shared that it was under 30 spots that are taken by patios. The ticket price does not deter the parkers. The City by-law officers are not permitted to ticket in private lots. Councillor Ingram will bring this to the new Council.

Struggles with Illegal Dumping

The Centre Mall is also struggling with illegal dumping in, and beside if the bins are locked, their large waste receptacle (e.g., couches). Ryan Erb shared that some downtown residents aren't able to afford the tags. This idea conflicts with the City's reports about waste reduction if the waste is going to private businesses. The BIA Beautification Sub-Committee can brainstorm and review this situation.
